What personal information do we collect?

Do we use third party analytic services?

Yes, we use Google Analytics to help us better understand how you use the Site. This may mean that a cookie is placed in your browser to collect information such as how you were referred to the Site, how you navigate around the Site, what you purchase and what traffic is driven by various marketing methods.
